



## 1 Purpose of this Document

The following is the text of a safety notice and liability disclaimer that will accompany all *iCub* humanoid robots distributed to all parties that have physical access to and use of the *iCub* cognitive humanoid robot.

## 2 Safety Notice

The *iCub* humanoid robot is a potentially dangerous device. It comprises multiple moving parts which may make sudden or unexpected movements if not controlled properly by the user, the user's software, or the software supplied with the *iCub*. The speed and force of these movements may cause severe injury. The user must exercise the utmost care and caution at all times when using the *iCub*. Only persons who are familiar with the operation and control of the *iCub* should operate it. No unsupervised persons should be allowed within one metre of the *iCub* while power is applied to the device.
